

Town of Granville 2024 west hill extension stone lined  
ditch and culverts replacement **contract**

The Town of Granville is seeking bids for a stone lined ditch and 4 culverts, **to be replaced, on West hill extension.**

Firms **interested** in the contract must submit a bid on the attached **form**. The bid **form** must be filled out completely. Please use ink or a typewriter. If you make a change the **person** making the change must initial it.

The bids will **be received at** the Granville Town Office, 4157 Vermont Route 100; Granville VT 05747 by **5:30 pm On April 4, 2024**. The bids will **be** opened and read in public **at** this time. Bids must **be** in a **sealed** envelope clearly marked "Town of Granville 2024 West hill extension". Do not fax your bid. Emails can be submitted in PDF form to [Granvilletown@gmavt.net](mailto:Granvilletown@gmavt.net). Use "Granville 2024 Paving" on the subject line. It is the **bidders** responsibility to confirm the town has **received** the bid and **it can** be opened and **read**. Emailed bids will be opened and printed at the time **set** for the actual bid opening.

**If the contractor** has questions regarding the instructions or specifications for this bid; **they** should be directed to **Ken Beattie at [Kensinsurance@gmail.com](mailto:Kensinsurance@gmail.com)**. There is no pre-bid **meeting**. Bidders should visit **the roads** and familiarize themselves with the existing conditions.

The selectboard of Granville reserves the right to **reject any and all bids or to waive any** informality when they deem it to be in the best interest of the town. Also the town **reserves the right to alter or reduce the contract**. Award of contract, if made, is **expected** at the following Granville Selectboard meeting.

Contract to be **completed by September 30, 2024**.

The **town** of Granville will institute a penalty of \$500/day for each day beyond the completion **date** stipulated for this contract. **The** contractor may request **an** extension caused by **an extraordinary** amount of inclement **weather**, the town not **being** ready, or due **to** extraordinary delays caused by covid-19 such **as a government** mandated shut down of **work** or **shortage of** materials. No extension **requested after the** completion **date** will **be** considered. Contractor must notify **the town at least 1 week prior to starting any work**.

The West hill extension road may be closed within the hours of 8 am and 4 pm to complete this project. warning of the road closure is the responsibility of the contractor. Warning must be given 4 days before the start of the project.

It is the contractor's responsibility to familiarize themselves with the **roads** and the **project**. **Please** call **Ken** Beattie at 1-802-349-3676 if you have questions or want to view the roads with the town **representative**.

**Contractor** must supply the Town with an insurance **certificate of at least \$1,000,000.00 Coverage** in workman's compensation, automobile liability and **general** liability prior **to** commencement of work listing **the** Town as an additional insured.

#### **Roads and treatments**

Remove material and shape ditch line, Truck material to designated area.

Place 7" to 12" erosion stone in ditch shape to specification .1975 lineal ft, place stone below the graded portion of the road.

Replace culvert #1 - #3 - #4 - #6 stone line inlet and outlet, use 1 load approximately 14 yds of crushed gravel per culvert, Town of Granville To provide culvert's, and the crushed gravel.
