- Grant Update Bruce indicated that Rita Seto of TRORC prepared a grant for culverts and ditching on Butz Road and we need to advertise soon. Mike inquired about a culvert inventory which was updated in 2019 and Rita updates each year with the culvert work performed. After a discussion of culverts and ditches needing to be cleaned Bruce will give Travis a call.
- Bank Accounts Update Bruce and Nancy met with the bank and they will be submitting a proposal.

• TRORC Update – GVFD Grant Sarah contacted Senator Sanders office to see about an earmark through federal funding using USDA Community Facilities which is capped at 35% and the Town would have to raise the rest before they will give out the grant. The Town might be able to apply to the Wastewater State Revolving Fund through the Agency of Natural Resources and/or Preservation Trust. Most of what the State Revolving Fund would offer would be loans. Preservation Trust grant is for rural construction projects having a 501c3 Non-Profit spear head the project up to \$500,000.00/town.
