The legal voters of the Granville Hancock Unified School District, consisting of the towns of Granville and Hancock, are hereby notified and warned to meet at the **Hancock Town Hall on** Way 13, 2025 at 5:00 PM to consider and act upon the following articles (1-11)

To be acted upon on May 13, 2025:

- Article 1: To elect a moderator who shall assume office immediately and serve a one-year term or until the election and qualification of a successor.
- Article 2: To elect a School District Clerk who shall assume office immediately and serve a one-year term or until the election and qualification of a successor
- Article 3: To elect a School District Treasurer who shall assume office immediately and serve a one-year term or until the election and qualification of a successor.
- Article 4: To fix the salaries of the School District Officers in the amount of \$1,000 each for the 2025-2026 school year.
- Article 5: To fix the salary of the School District Treasurer in the amount of \$3,200 for the 2025-2026 school year.
- Article 6: To hear and act upon the reports of the School District directors and officers.
- Article 7: Shall the voters authorize the School Board to borrow money by issuance of notes not in excess of anticipated revenue for the fiscal year July 1, 2025 through June 30, 2026 per 16 V.S.A. §562(9).
- Article 8: Shall the voters of the school district approve the school board to expend \$2,290,856 which is the amount the school board has determined to be necessary for the ensuing fiscal year? The Granville Hancock Unified District estimates that this proposed budget, if approved, will result in per pupil education spending of \$11,794.47, which is 1.24% lower than per pupil education spending for the current year.
- Article 9: To elect Directors to the Granville-Hancock Unified School District as follows:

Granville 1 Director for a three (3) year term. Hancock 1 Director for a three (3) year term;

Article 10: To transact any other business which may legally come before this meeting.

A ticle 11: To adjourn the meeting

The legal voters of the Granville Hancock Unified School District are further notified that voter qualification and registration relative to said meeting shall be as provided in Section 706(u) of Title 18, and Chapters 43, 51 and 55 of Title 17, Vermont Statutes Annotated.
