Minutes
February 12, 2026

1. **Call to Order** - 10:00am Veronica Parrish & Kate Stauss in attendance
2. **Minutes of 10/14/25** - Approved as written.
3. **Financials** - Vic made a motion to reimburse Dan Mutchler \$647.88 for rental of Dingo bucketloader in order to dig a grave in June, over and above the monies paid to him by the funeral home. Kate seconded. All in favor.
4. **Old Business**
 - A. Review proposed Sexton contractThe board drew upon exemplars from at Morristown, Brookfield and Plainfield to create a job description for the sexton.

Candidates should have good communication skills, organizational skills, and ability to follow all pertaining statutes as required by Vermont law.

Duties include:

- 1) Check on cemeteries at least once a month from May through October and report to Commissioners if maintenance needs to be done.
- 2) Meet with buyers to locate, discuss and sell lots and report to Commissioners.
- 3) Consult with Monument Company about placement of corner marker and monument, and report to the Cemetery Commission of same.
- 4) Place flags before Memorial Day and remove them in November.
- 5) Open and close grave lots; backhoe to be reimbursed by Cemetery Commission with prior approval. (This may be conditional upon further research with the funeral home.)
- 6) Instruct vault drivers on location of graves.
- 7) Keep cemetery maps up to date in coordination with Commissioners.

Contract would include a small stipend to incentivize the annual work that is not included in burials. Kate will draft a proposed contract and circulate via email to the Commissioners. The contract will be revised and/or approved at our next meeting.

B. Review Revision of Granville's Bylaws, Sections II and III

- Propose a date for postponed South Hollow Cemetery Community Cleanup. Kate moved to table to next meeting. Vic seconded. All in favor.
- Discuss possible hand-out at Town Meeting. We don't have enough to report out yet. We will be having a warned meeting - as mandated by law - when we have completed the Bylaw revisions.

6. **Any other necessary business**

Over the course of the meeting the following ideas for cemetery improvement were mentioned, to be discussed in future meetings: signs for the cemeteries with the names and hours, benches for the cemeteries, fences along the road North Hollow and Elmwood Cemeteries, and plats of all cemeteries.
